NOTES FROM THE (SNOW-COVERED) FIELD

Greetings from the farm!

I hope you are enjoying the winter months and taking advantage of all the snow we have been receiving. I have been appreciating the rest and relaxation that comes along with the snow and have been spending my time reading, skiing, visiting friends and in the recent weeks, planning for the 2008 growing season.

Reflecting on the 2007 season, I am very content with how my first year as an independent farmer unfolded. There were, of course, some trials and tribulations, but these were overshadowed by the many successes that come along with a bountiful and enjoyable season. I hope that you were all content with the vegetables you received and enjoyed participating in reroot organic CSA.

As a follow-up to the 2007 season, I conducted a price analysis on the shares you received. I tallied up the contents of the shares for the season; assigned a value to each crop (based on organic farmer's market prices for

2007, available from the Ecological Farmers' Association of Ontario); and came up with a total market value of \$996.78 for the season. This value does not include the cut-flowers or any u-pick opportunities that were available. This is obviously a huge savings on a \$600 share, and in my first growing season I am very happy to have passed that savings along to my shareholders.

At the completion of the season, many of you filled out an 'End-of-Season Survey". There was much good feedback offered and I am incorporating all of your suggestions as I plan for 2008. Some feedback to note is that a number of you felt the share size was "a little heavy"; almost all of you described the quality of vegetables as "always excellent"; and finally there were some suggestions of new crops to grow, including corn, more sweet potatoes, rosemary, asparagus, fruit, and garlic. In response to this feedback we will be adjusting the share size slightly so as to more accurately reflect the market value, while still offering

you great savings; we'll continue to strive for the best quality; and we will be adding some new crops to the roster including strawberries, corn, garlic, hopefully more sweet potatoes (we're starting the slips next week!), and more.

2008 will also see the addition of a new co-manager (please see Devan's biography below) and some new infrastructure to the farm including a wash station and CSA pick-up shed that will double as market stand from which to sell any excess produce. We will also be frequenting the Elora Farmer's Market with excess produce, but want to ensure you that the CSA remains our first priority. Finally, in terms of size, reroot will be growing from 20 shares in 2007 to 60 shares in 2008. Registration forms have started rolling in, so please send in your form and deposit early to ensure a share.
